



GET BIG BENEFITS FOR YOUR SMALL BUSINESS.

The road to qualifying is easy. Here's how:

If you're a registered business entity and will be using your vehicle in the day-to-day operation of your business, just bring a copy of any one of these completed documents to your dealer. (If you are purchasing a vehicle in your individual name, you must provide proof of proprietorship to document that you are the business proprietor.)

Eligible documentation includes:

- Copy of government document showing business tax identification number and business name
- Business incorporation documents
- State, county or municipal business license
- Copy of government document showing nonprofit tax identification number and business name
- Federal or state income tax forms showing operation as a business entity
- Enrolled BusinessLink customer number
- A fleet account number
- Business license
- Copy of DBA or assumed-name documentation
- Sales tax license
- Workman's compensation/commercial general liability insurance
- State or federal forms with federal tax ID
- A complete copy of the most recent original tax return Form 1040 and all related schedules (including Schedule C or F) that were filed with the IRS
- A copy of an official government website document verifying the customer's business
- NOTE: Commercial driver's license is no longer eligible

If you are purchasing or leasing a vehicle, you must be a qualified business customer for more than 30 days prior to the date of vehicle purchase. There is no limit to the number of vehicles you are permitted to purchase or lease and receive the benefits of the On The Job program.

NOTE: 3500/4500/5500 Chassis Cabs with upfit do not require proof of eligibility.

All 2015 MY Chrysler, Dodge, Jeep, Ram, FIAT brand vehicles (excludes Viper & SRT models) (effective until 1/4/16)

- A minimum of \$250, \$500 or \$1,000 in Vehicle Graphics must be installed to be eligible for the \$250, \$500 or \$1,000 Commercial Graphics Program. 2015 Ram ProMaster City™ only eligible for \$250 and \$500 allowance. 2015 MY Dodge Dart and FIAT 500 are only eligible for the \$250 allowance (not available on Dart SE and FIAT Abarth)
- Customer/dealer must provide an invoice from the installer to validate spending and eligibility of any and all vehicle graphics
- The dealer must have documentation that the graphic was purchased/installed with a value equal to or greater than:
 - \$250-\$499 to be eligible for the \$250 allowance
 - \$500-\$999 to be eligible for the \$500 allowance
 - \$1,000+ to be eligible for the \$1,000 allowance
- Claims will be reimbursed in the amount of \$250, \$500 or \$1,000 depending upon the customer's graphic spend amount and claim submitted
- Commercial Graphics Allowance must be processed at time of sale

\$500 RAMBOX® CARGO MANAGEMENT SYSTEM ALLOWANCE

Ram 1500 Crew Cab Pickup
Ram 1500 Regular Cab, Ram 1500 Quad Cab, Ram 2500 Pickup, Ram 3500 Pickup—all with XB9 (effective until 1/4/16)

- Consumer business cash allowance for all eligible Ram cab models with the RamBox® Cargo Management System
- Ram 1500 4.7L Tradesman comes standard with RamBox® Cargo Management System
- Cash allowance of \$500 must be applied to the sale and paid to the dealer

\$1,000 UPFIT ALLOWANCE

\$1,000 COMMERCIAL EQUIPMENT / UPFIT / SNOW PLOW / FACTORY BOX OFF ALLOWANCE

Eligible Models: 2015 MY
Ram ProMaster®, Ram C/V, Ram 2500 Factory Box Off, Ram 3500/4500/5500 Chassis Cab, Ram 2500/3500 4x4 Pickup with Snow Plow prep group AHD or Snow Chief group (effective until 1/4/16)

- Primary applications for a Ram 2500 Pickup Heavy Duty Factory Box Off process involve, but are not limited to, service bodies, platform bodies (without hydraulic lifts), dump bodies and stake bodies. The vehicle cannot exceed the rated GVWR and GCWR
- A minimum of \$1,000 in eligible upfit equipment must be installed to be eligible for the \$1,000 upfit allowance
- Installation of eligible upfits must be performed by a factory-approved upfitter to be considered for eligibility
- The dealer must have an invoice documenting any or all equipment and body installation costs
- Commercial/upfit allowance must be processed at time of sale
- Factory Box Off Ram 2500/3500 4x4 Heavy Duty Pickup Trucks with Snow Plow

\$1,000 ALLOWANCE

\$1,000 FIELD BOX OFF ALLOWANCE

Eligible Models: 2015 MY
Ram 2500 Pickup, Ram 3500 Pickup (effective until 1/4/16)

- Box removal and replacement on the Ram 2500 Heavy Duty Pickup is intended for a limited selection of upfit body applications of limited weight ranges. The primary applications for the Ram 2500 Heavy Duty Pickup box removal and replacement program involve service bodies, platform bodies (without hydraulic lifts) and stake bodies
- This application should NOT be used for the following upfit bodies: boom trucks, cranes, dump trucks, platform lifts, wrecker bodies, ambulance, motor home or recovery vehicles. These applications could adversely affect the performance of the vehicle, vehicle systems and void the manufacturer's chassis warranty. Body manufacturers and upfitters should ensure that appropriate warning labels and customer information be provided to inform the end customer of permissible payload and towing capacities to ensure that the vehicle in service does not exceed the rated GVWR and GCWR

\$500 UPFIT ALLOWANCE

\$500 RETAIL COMMERCIAL EQUIPMENT / UPFIT ALLOWANCE

Eligible Models: 2015 MY
Journey, Durango, Ram C/V, Ram 1500/2500/3500 Pickup, Ram 2500 Pickup Factory Box Off, Ram 3500/4500/5500 Chassis Cab, Ram ProMaster®, Ram ProMaster City,™ Grand Caravan, Town & Country (effective until 1/4/16)

- Upfit costs must equal or exceed \$500 and reflect installation of the following (but not limited to): tool box, ladder rack, liftgate, exterior shelving and floors, bulkhead divider, overhead utility racks, bedliner, underseat storage, bed extender, trailer hitch mount package, running board/assist steps, tie down/tow hooks, cargo organizers, bed divider, cargo management systems, cargo partition, rubber flooring or shelving
- Commercial/upfit allowance must be processed at time of sale
